10. STABILITY AND REACTIVITY

Stable under the recommended storage and handling conditions (see section 7). In a fire, hazardous decomposition products such as smoke, carbon monoxide, carbon dioxide and oxides of nitrogen may be produced. LEAD IN PREVIOUSLY PAINTED SURFACES

The Code of Practice for the Control of Lead at Works (reference ISBN 07176 1506 5 1998) should be consulted for advice on protective clothing and personal hygiene precautions.
