3 HAZARDS IDENTIFICATION

Flammable. Repeated exposure may cause skin dryness or cracking. Harmful: may cause lung demage if swallowed.

4 FIRST-AID MEASURES

GENERAL INFORMATION

Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INHALATION

INGESTION

SKIN CONTACT

Make sure to remove any contact lenses from the eyes before rinsing. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention.

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA

Fire can be extinguished using: Foam. Dry chemicals, sand, dolomita etc. Water spray, fog or mist. DO NOT use direct water jet as this will scatter and spread the fire.

SPECIAL FIRE FIGHTING PROCEDURES

Avoid breething fire vapours. Cool containers exposed to flames with water until well after the fire is out. Keep run-off water out of sewers and water sources. Dike for water control.

UNUSUAL FIRE & EXPLOSION HAZARDS

Vapours are heavier than air and may spread near ground to sources of ignition. May travel considerable distance to source of ignition and flash back. May form explosive mixture with air particularly with in empty uncleaned receptacles.

PROTECTIVE MEASURES IN FIRE

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

Ventilate area, Avoid breathing vapours. Remove all sources of ignition. Wear suitable protective clothing as specified under section 8 of this safety data sheet - Exposure Controls and Personal Protection.

SPILL CLEAN UP METHODS

Wear necessary protective equipment. Absorb in vermiculite, dry sand or earth and place into containers. Dispose of in accordance with Local Authority Regulations via a licenced waste cerrier. Do not contaminate water sources or sewer.

INHALATION
