Application

- 1. Shake bottle before use and remove cap.
- 2. Squeeze the bottle to fill the dosing cap and add the contents to a bucket of water (up to 20 litres) and stir.
- 3. Stir well and add the gauging solution to the dry mix as required to achieve the desired consistency.
- 4. The recommended addition rate is 10ml per 25kg cement.
- 5. Replace lid on cup when finished.
- 6. Add to the mix to ensure good dispersal and to obtain the mortar consistency required.

1. Clean tools and equipment immediately after use with water.
