Application

- Shake well before use.
- Add 85-90ml of Sealocrete Sealomix per 25kg of cement.
- 3. When using Sealocrete Sealomix 10-15% less water is usually required.
- 4. Bricklaying 1 part cement to 6 parts sand plus Sealocrete Sealomix (as above).
- Plastering Internal floating coats and external rendering – 1 part cement to 6 parts sand plus Sealocrete Sealomix (as above). For roughcast use 1 part cement to 4.5 parts sand plus Sealocrete Sealomix (as above).
- 6. Sealocrete Sealomix does not change the colour of the mortar. Sealocrete Sealomix is free from chlorides so can be used with metal reinforcement.
